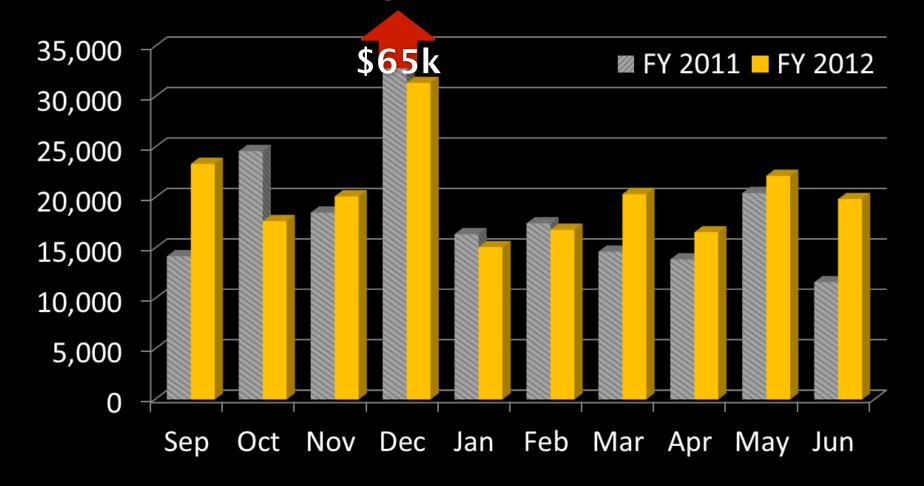

FY 2012 Giving vs. Prior Year



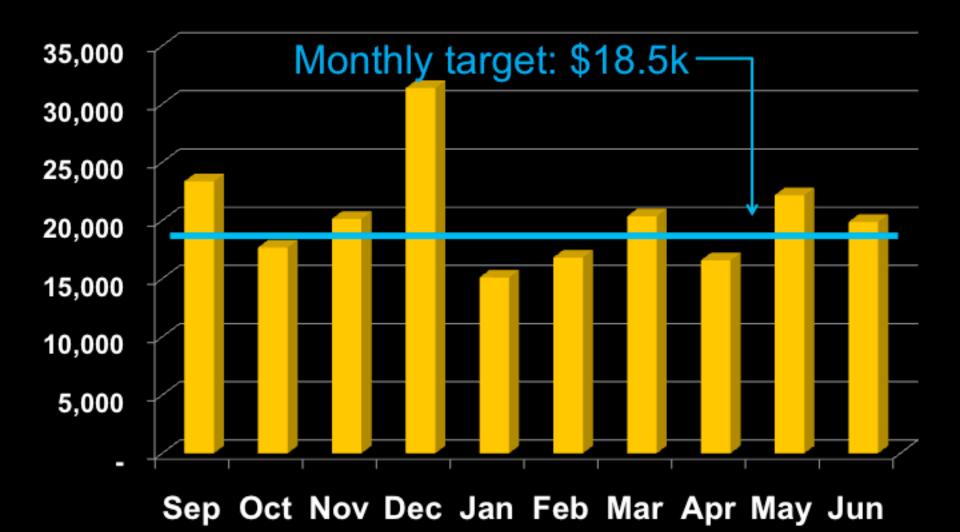
Vox YTD Giving vs. Prior Year
